Oakwood Creek Estates Assessment Update

The Oakwood Creek Estates assessment was approved by Commissioners' Court on September 14, 2010 in response to a referendum of 77 FOR votes and 19 AGAINST votes. 152 ballots were sent out. Immediately following the election the project consultants began finalizing the engineering plans and preparing the legal descriptions for drainage easements. The County expects delivery of the preliminary plan and profile engineering drawings during the third week of January. The legal descriptions for 23 parcels and the

drainage survey were received by the County on November 30, 2009. The drainage easement deeds were prepared and contact with property owners began. We will continue to speak with property owners about signing easement deeds. All owners of parcels needed for the drainage system have been contacted by phone and/ or mail. Four easement deeds have been signed. Our consultant will continue work on the engineering plans. As soon as all the easement deeds have been acquired and the engineering plans are complete the County will begin construction of the drainage system. We understand that you have received your first assessment statement. Be assured we are working on this project daily. The work that is occurring at this time is on paper. The design process and legal paperwork required for building a well maintained drainage system is time consuming and essential in providing a well built road.

By Law Amendment

The following changes regarding meetings have been made to our By Laws:

Meetings of the Board of Trustees would be held every other month instead of monthly. In addition, the term of office would be four (4) years instead of the current two (2) years.

These changes would allow for the same number of meetings (24) with a less frequent turn over of members on the board. Meeting less frequently, but for a longer term would still allow board members to acquaint himself or herself to the duties of the Board.

Finally, there are a limited number of quali-

fied property owners who are willing and able to serve on the board which under the current schedule we quickly deplete and have frequent turnover of eligible candidates.

Deed Restrictions

■ As a reminder per section 13 of our deed restrictions: "No animals, livestock or poultry of any kind shall be commercially raised, bred or kept on any lot except that dogs, cats and other household pets (not to exceed two of each category) may be kept, provided that they are not allowed to roam or wander unattended in the neighborhood"

■ In addition please review section 1. Land Use and Building Type. Which prohibits commercial business and professional uses from homes, residences or otherwise.

Heavy Trash Pickup

For Property Owners who reside in the Brazoria County portion of our community on Jamison and Lakewood Drive, heavy trash pickup for 2011 will occur twice a year and at the same time as for the residents in Baileys Prairie. The dates posted for the heavy trash pickup are the 3rd week in April and the 3rd week of November. However, we have been informed that April's pickup will be Saturday the 16th of April for all of Baileys Prairie and all of Oakwood Creek Estates including Jamison Drive and Lakewood Drive.

Signs will be posted in advance as a reminder and the website will also be kept current with this information.

A reminder that the heavy trash pickup services will not pick up tires or chemicals. There are several options for disposing of used tires including: the Brazoria County Solid Landfill (864-4442) will accept the tires if they are on a rim, or if they are cut into quarters. You may also recycle the tires at the Wal-Mart auto center in Angleton (849-2756) for 70 cents per tire. Finally, you may recycle up to 4 tires for free at the semi-annual Brazoria County recycling day that is advertised in The Facts.

A couple of important reminders:

- Heavy trash can be placed on either side of the street for pickup.
- Trash should be placed <u>on the ground</u> for pickup. Please do not place your trash in a trailer. They do not want to risk damaging your personal property when picking up the trash.
