Heavy Trash Pickup

For Property Owners who reside in the Brazoria County portion of our community on Jamison and Lakewood Drive, heavy trash pickup for 2014 will occur twice a year and at the same time as for the residents in Baileys Prairie. The upcoming date for heavy trash pickup is the 3rd week of November.

Signs will be posted in advance as a reminder and the website will also be kept current with this information.

Heavy trash pickup services will not pick up tires or chemicals. There are several options for disposing of used tires including: the Brazoria County Environmental Center who will accept the tires if they are on a rim, or if they are cut into guarters. A few more reminders:

- Heavy trash can be placed on either side of the street for pickup.
- Trash should be placed on the ground for pickup. Please do not place your trash in a trailer because they do not want to risk damaging your personal property when picking up the trash.

Trick or Treating Clarifications

Every October one of our wonderful Oakwood Creek residences volunteers to host the annual meeting/Halloween event at their home. At this event, we have a catered meal for all who attend and we follow with a short property owner's business meeting. Once business is taken care of, several of our parents load the kids up on hay covered trailers
