# Local Pets Killed and Injured

How would you feel if you came home to find your favorite pet killed or maimed by another animal that had ventured onto your property? Do you know where your pet is when you are not at home? It is sad to report that even after the reminders posted in the Newsletter over the past year, the community is still having problems with pets roaming outside owners' property. The problem has escalated over the past month such that we have now had pets injured and killed in Oakwood Creek. The following points cannot be over emphasized:

- Brazoria County and Texas law states that animals must be contained to the owner's property and not allowed to roam at large.
- First time violators can receive up to a \$500 fine per offense.
- If you see stray animals roaming the neighborhood, please check with neighbors to make sure they know a pet may have escaped. If it is a stray animal, please contact the Brazoria County Sheriff's Office.

We know that you want your animals to live long and happy lives. Please help keep the pets in our community safe by ensuring that your pets stay on your property. Thank you for your help in making Oakwood Creek a more enjoyable and safe place to live.

### Roads and Drainage


Anyone felt like they were driving through an obstacle course on the way home lately? Many of you have been asking about how the community can move forward with road and drainage improvements, especially on Rucks and Coleman roads. We have heard your comments and have been working towards a solution. This Fall the Board met with the Brazoria County Engineer, Gerald Roberts, to discuss drainage and road problems in our subdivision. Gerald was very helpful in explaining the process for our subdivision to upgrade the roads. As many of you already know, the roads and drainage along Rucks and Coleman are not maintained by the county are the responsibility of the Village of Bailey's Prairie. Since Bailey's Prairie does not collect a tax or have the income necessary to repair the roads, the repair must take place through an interlocal agreement with Brazoria County, and an assessment of the land owners along the affected roads. The first step in the process is for the residents of Oakwood Creek Estates to officially petition Bailey's Prairie
